The personal information you have provided in your Melbourne Vixens Association Membership application is collected, used and disclosed in accordance with the [Netball Australia Privacy Policy](#) – Netball Victoria is a party to this policy.

Netball Victoria may use and disclose your personal information for the purposes of conducting and administrating your Melbourne Vixens Association Membership and other related activities across Australia, providing you with member services or promotional materials, and complying with legal obligations or otherwise in accordance with the Netball Australia Privacy Policy. Netball Victoria may share your information with third parties such as Netball Australia or Ticketek, however your information is not generally disclosed to anyone outside Australia. The Netball Australia Privacy Policy contains information about how you may access, and request correction of your personal information held by Netball Victoria or make a complaint about the handling of your personal information and provides information about how a complaint will be dealt with by Netball Victoria. Your Association Membership application may be rejected if this information is not provided. If you do not wish to receive promotional material from Netball Victoria sponsors and third parties, you must advise us via email or telephone, or via the specific opt-out procedures provided in the relevant communication.
